

FEE BYLAW

Village of Meath Park

BYLAW # 04-2023

A bylaw of the Village of Meath Park to provide for the collection of service fees as provided for in section 8 subsection 1 clause (i) of the *Municipalities Act*.

The Council of the Village of Meath Park in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be known as the "Fee Bylaw."


