

VILLAGE OF MEATH PARK
BYLAW 01-2023

A BYLAW TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF SERVICE CHARGE FOR THE USE OF THE SEWER.

The Council of the Village of Meath Park in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be known as the Water and Sewer Rate Bylaw.
2. All persons desiring to receive water and sewer shall apply in form as per Schedule "A" attached hereto and forming part of this bylaw. This application shall be accompanied by a deposit in the amount of \$125.00.
3. The Village of Meath Park may by bylaw, ration or limit the amount of water furnished to any and/or all consumers should circumstance deem to warrant such action.
4. If the water supply is shut off from the premises of a user for infringement of the provisions of this bylaw, same shall not be turned on until penalties, fees, rates, charges, custom labor and/ or arrears if any have been paid.
5. The charges to be paid by the water consumer whose water service has been turned on and for persons who own or occupy premises drained or that are by bylaw to be drained into the sewer shall be those set out in schedule "B" attached or amended from time to time.
6. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such service in a rental rate or service charge in accordance with Schedule "C" attached or as amended from time to time.
7. Persons who own or occupy premises that require water and sewer services to the premises shall pay an infrastructure fee in accordance with schedule "D" attached or as amended from time to time.
8. Accounts for water service and/or sewer service shall cover a period of three successive months and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the said period of thirty days, the water service may be cut off. When the water service is cut off; it shall not be resumed until 50% of arrears have been paid together with a fee of \$100.00 to cover expenses of turning off water and turning it on again: provided that if the Village is required to turn on the said water service outside the Village employee's regular working hours the fee shall be \$150.00.
9. Water and sewer services can be disconnected at any time at the discretion of the Village of Meath Park.
10. Water and sewer services are deemed to be a service to the owner of the land and/or buildings and all accounts for rates, costs or charges relating to providing these services shall be in the name of the owner, payable by the owner and collectible from the owner.

11. The sewer line from a house to the main sewer line on the street is the responsibility of the homeowner to keep clear. The Village of Meath Park is not responsible for sewer line cleaning for residents no matter where the blockage is thought to be.
12. All water and sewer accounts are due and payable when rendered. If the account shows arrears of thirty days after the billing date a 3% penalty shall be added monthly to the arrears.
13. If an account shows arrears after December 31 of the year in which the charges are incurred, the balance will be transferred to the property tax account at any time after that.
14. THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.
15. Bylaw No. 08-2021 and 8/2018 are hereby repealed.







